After being appointed Assistant Commissioner in 2013, he became responsible for managing all aspects of interagency humanitarian logistics, supply chain logistics, and resource management and planning as part of the NYC Citywide Logistics Program (CLP). During his tenure at NYCEM, Jenkins responded to various disasters and emergencies in NYC and around the country, including building collapses, wildfires, winter weather, tornadoes, hurricanes (most recently Hurricane Maria in Puerto Rico), and various planned events.

Some of his lasting initiatives include a program to build the City's all-hazards Emergency Supply Stockpile (ESS) for response and recovery operations, planning for and building the City's Logistics Center (LC) for disaster logistics operations during emergencies, and developing a lasting and strategic partnership between NYCEM and the Massachusetts Institute of Technology (MIT) Humanitarian Supply Chain Laboratory. He was also one of three Deputy Commissioners for the New York City Emergency Operations Center (EOC), leading hundreds of agency partners during responses.

Jenkins also served on various city, state, and federal committees and advisory boards including the Port of New York and New Jersey Area Maritime Security Committee (AMSC). He was also a representative for the Big City Emergency Managers (BCEM) on the National Emergency Management Assistance Compact (EMAC) Advisory Group.

Jenkins has held positions as an emergency planning consultant at the U.S. Senate Office of Security and Emergency Preparedness in Washington, DC; as an emergency management consultant for the Federal Emergency Management Agency (FEMA) National Incident Management System (NIMS) Integration Center (NIC) in Washington, DC; and as a bioterrorism consultant for the U.S. Department of Defense (DOD) Joint-Base Readiness Program in McLean, VA.
